Motion by Besch and 2<sup>nd</sup> by McGregor to approve the agenda with the 9:35 a.m. and the 11:35 a.m. canceled. Ayes all, Nays none. Motion carried unanimous.

Public Discussion and Committee Reports were held.

Motion by McGregor and 2<sup>nd</sup> by Plathe to set 1:00 p.m. March 8, 2005 for the Budget Hearing in the Courthouse Assembly Room. Ayes all, Nays none. Motion carried unanimous.

CBM Food Service Group gave a presentation on Inmate Food Service and the services they could provide. They would need to have numbers using the service before cost could be discussed.

Josh Kohlhaas, Regional Planner for NIACOG held a Community Builder Plan Session to get goals and strategies from the Supervisors and Department Heads and Economic Development. Section 1 involved Community Development, Section 2 involved Community Infrastructure & Services, Section 3 involved Social Services, Cultural Features, & Recreation, Section 4, Local Government Finances, Section 5, Economic Development, and Local Government Finances.

Motion by Froehlich and 2<sup>nd</sup> by McGregor to approve Conservation to apply for a USDA Grant for a storm cellar in the lower level of the Nature Center. Ayes 4 Nays 1. Roll Call Vote: Besch no, Froehlich yes, McGregor yes, Plathe yes, Elsbecker yes. Motion carried.

An Ordinance placing conditions on the sale of products containing pseudoephedrine in combination with other active ingredients was presented by the Sheriff and County Attorney. This will be published and a Public Hearing will be held.

Motion by McGregor and 2<sup>nd</sup> by Plathe to approve the Fiscal Year 2006 Kossuth County Secondary Road Budget and Construction Program and recommend approval by the Iowa Department of Transportation. Roll Call Vote: Plathe yes, McGregor yes, Froehlich yes, Besch yes, Elsbecker yes. Motion carried unanimous.

A Keg Ordinance was presented to the Supervisors providing for the Registration and Documentation of Retail Sales of Keg Alcoholic Beverages and Imposing Penalties for Violations Thereof. This will be published and two readings held.

Representatives from Kossuth Connections gave a presentation. Kossuth Connections represents the entire county to make Kossuth County a safe, healthy, crime and drug-free place to raise children, live and work. They requested \$10,000 to help match a five year Grant of \$50,000.

On motion adjournment was taken until February 7, 2005.
