Sharon Bowlin, account consultant with Wellmark, Blue Cross, BlueShield gave the Supervisors a financial and utilization summary of the county health insurance.

Motion by Plathe and 2nd by Froehlich to agree to the terms set forth in Iowa Department of Transportation Federal-aid Agreement for a County Highway Bridge Replacement and Rehabilitation (HBRR) Program Project, Project No. BRS-C055(116)—60-55, Iowa DOT Agreement Number 2-05-HBRRS-048 and to authorize the chair to sign the agreement for Kossuth County, Iowa.
