WHEREAS, election workers provide an invaluable function to our country and are one of this country's most valuable resources; and

WHEREAS, election workers volunteer to serve their fellow citizens with distinction and provide an invaluable service to their communities; and

WHEREAS, election workers span the generation gap from high school students to senior citizens and mirror the amazing diversity of their communities and American society as a whole; and

WHEREAS, election workers are the backbone of American democracy and their dedicated service allows our democracy to flourish; and

WHEREAS, election workers are America's "champions of democracy," it is most appropriate to recognize the contribution that election workers make each time we cast our votes:

NOW, THEREFORE, BE IT RESOLVED that the Kossuth County Board of Supervisors, in concert with the states, counties and election jurisdictions of the United States, proclaims the week of November 5-11, 2006 as "National Election Worker Appreciation Week."

Motion by Elsbecker and 2nd by Besch that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Humboldt County Rural Electric Cooperative, Humboldt, IA, to install a 7,200 volt single-phase overhead line. Work will begin 500' south of the intersection of 150th Street and 180th Avenue and extend south for approximately 2,200' in the West right of way of 180th Avenue, Section 11, Sherman Township. Service is for a new confinement site. Permit number 06-11-48 is on file in the Kossuth County Engineer's Office. Ayes all, Nays none. Motion carried unanimous.

Robert Payne representing Kensington Industry and Investments gave an overview of Kensington Industry and Investments, LLC and their plans for the Galbraith area to build an Ethanol Plant. They project the plant will use 37 million bushels of locally-purchased corn annually. Galbraith ethanol operations will generate over \$200 million in annual revenues and roughly 40 high quality skilled jobs created upon commencement of operations, with aggregate annual payroll of \$1,500,000.
