Motion by Plathe and 2nd by Loss to approve the 2022 Homestead & Military disallowances and approvals. Motion carried unanimously.

Motion by Stecker and 2nd by Tjarks to accept the Central Iowa Juvenile Detention Center Audit. Motion carried unanimously.

Motion by Casey and 2nd by Tjarks to have IT Coordinator Derek Olson purchase the devices necessary to record the board of supervisor meetings. Chairman Tjarks called for a roll call vote: Stecker: yes, Casey: yes, Loss: yes, Plathe: yes, Tjarks: yes. Motion carried.

Held discussion with Kossuth County Attorney Todd Holmes on a policy for animals in the Kossuth County Courthouse. Attorney Holmes will add a penalties section to the policy and bring it back to the board for further discussion.

Motion by Casey and 2nd by Loss to authorize and give its permission to Interstate Power and Light, Britt, IA, to complete the following on 105th Street approximately 290 feet east of 115th Avenue in the south right of way: install one pole and replace one pole to build a platform to mount three voltage regulators. Work will be in Section 35, Riverdale Township. Permit Number 10-32-2022 is on file in the Kossuth County Engineer's Office. Motion carried unanimously.

Motion by Tjarks and 2nd by Stecker to approve Resolution #10-04-22-01, which is a resolution to provide for the temporary closing of 210th Avenue due to culvert replacement. Chairman Tjarks called for a roll call vote: Stecker: yes, Casey: yes, Loss: yes, Plathe: yes, Tjarks: yes. Motion carried.

WHEREAS culvert replacement project LFM-C772106--7X-55 requires 210th Avenue between 300th Street (B19) and 310th Street closed to all traffic, and

NOW, THEREFORE, BE IT RESOLVED, by the Kossuth County Board of Supervisors that the above described roads be closed and proper signs be erected for the duration of the construction project as determined by the County Engineer.

BE IT FURTHER RESOLVED, that upon completion of the construction work, as determined by the County Engineer, the road shall be opened to the traveling public without further action of this board.
