BOARD PROCEEDINGS March 9, 2021 REGULAR March SESSION

The Board of Supervisors met pursuant to adjournment. Present were: Roger Tjarks, Chairman, Galen Casey, Kyle Stecker, Donnie Loss and Jack Plathe.

Chairman, Roger Tjarks called the meeting to order at 8:02 a.m. followed by the Pledge of Allegiance.

Discussion was held with the Secondary Road Foreman.

Motion by Loss and 2nd by Stecker to approve the agenda, the minutes of the previous meeting dated March 2, 2021 and approve the handwritten claim. Motion carried unanimously.

Vince Johnson was present and given a copy of the quote dated 11-20-20 for Swea Section 25 DD4 Dredge by Supervisor Stecker. A copy of the quote was added to the drainage minutes.

Motion by Plathe and 2nd by Tjarks to approve the Meeting/Mileage Reimbursement Policy. Chairman Tjarks called for a roll call vote: Stecker: yes, Casey: yes, Loss: yes, Plathe: yes, Tjarks: yes. Motion carried.

Kossuth Regional Health Center presented their FY 2021 Financial Performance Report, Monthly Update and their FY 2022 Budget.

Motion by Plathe and 2nd by Stecker to approve Resolution #03-09-21-01 which is a resolution regarding payment of the expenses of operation, maintenance, and funded depreciation of the hospital from other county funds or by tax levy. Motion carried unanimously.

RESOLUTION #03-09-21-01

RESOLUTION REGARDING PAYMENT OF THE EXPENSES OF OPERATION, MAINTENANCE, AND FUNDED DEPRECIATION OF THE HOSPITAL FROM OTHER COUNTY FUNDS OR BY TAX LEVY

WHEREAS, Kossuth Regional Health Center is a hospital organized and operated pursuant to Iowa Code Chapter 347A; and

WHEREAS, Iowa Code Section 347A.3 provides:

If in any year, after payment of the accruing interest on and principal due of revenue bonds issued under chapter 331, division IV, part 4, and payable from the revenues derived from the operation of the county hospital, there is a balance of such revenues insufficient to pay the expenses of operation, maintenance, and funded depreciation of the hospital, the board of hospital trustees shall certify that fact as soon as ascertained to the board of supervisors of the county, and the board of supervisors shall make the amount of the deficiency for paying the expenses of operation, maintenance, and funded depreciation of the hospital available from other county funds or shall levy a tax not to exceed one dollar and eight cents per thousand dollars of assessed value in any one year on all the taxable property in the county in an amount sufficient for that purpose. However, general county funds or the proceeds of taxes shall not be used or applied to the payment of the interest on or principal of revenue bonds issued under chapter 331, division IV, part 4, but general county funds or proceeds of taxes may only be used and applied to pay expenses of operation, maintenance, and funded depreciation of the hospital which cannot be paid from available revenue derived from its operation; and

WHEREAS, the Kossuth Regional Health Center Board of Trustees have certified that after payment of the accruing interest on and principal due of revenue bonds issued under chapter 331, division IV, part 4, and payable from the revenues derived from the operation of the county hospital, there is a balance of such revenues insufficient to pay the expenses of operation, maintenance, and funded depreciation of the hospital; and

WHEREAS, the certified deficiency is \$962,127; and

WHEREAS, the Kossuth County Board of Supervisors is obligated to "make the amount of the deficiency for paying the expenses of operation, maintenance, and funded depreciation of the hospital available" from other county funds or by tax levy; and

WHEREAS, general county funds or proceeds of taxes "shall not be used or applied to the payment of the interest on or principal of revenue bonds issued under chapter 331, division IV, part 4, but general county funds or proceeds of taxes may only be used and applied to pay expenses of operation, maintenance, and funded depreciation of the hospital which cannot be paid from available revenue derived from its operation."

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF KOSSUTH COUNTY AS FOLLOWS:

- 1. That the Kossuth Regional Health Center Board of Trustees has certified to the Board the fact that after payment of the accruing interest on and principal due of revenue bonds issued under chapter 331, division IV, part 4, and payable from the revenues derived from the operation of the county hospital, there is a balance of such revenues insufficient to pay the expenses of operation, maintenance, and funded depreciation of the hospital.
- 2. That Kossuth Regional Health Center and its Board of Trustees is a "municipality" and a "certifying board" for purposes of Iowa Code Chapter 24. Therefore, they have the power to levy or certify a tax or sum of money to be collected by taxation. (See Iowa Op. Atty. Gen. 94-3-l(L))
- 3. That the Kossuth County Board of Supervisors shall make the amount of the deficiency for paying the expenses of operation, maintenance, and funded depreciation of the hospital available from other county funds or shall levy a tax not to exceed one dollar and eight cents per thousand dollars of assessed value in any one year on all the taxable property in the county in an amount sufficient for that purpose.
- 4. However, the general county funds or the proceeds of taxes shall not be used or applied to the payment of the interest on or principal of revenue bonds issued under chapter 331, division IV, part 4, but general county funds or proceeds of taxes may only be used and applied to pay expenses of operation, maintenance, and funded depreciation of the hospital which cannot be paid from available revenue derived from its operation.

The Maximum Property Tax dollars requested in General County Services does represent an increase of 1.99% and in Rural County Services an increase of 1.99% from the Maximum Property Tax Dollars requested in FY 20/21.

RESOLUTION IMPOSING A MORITORIUM ON THE FILING OR PROCESSING OF FURTHER NOTICES OF INTENT AND/OR APPLICATIONS FOR COMMERCIAL WIND ENERGY CONVERSION SYSTEMS UNDER KOSSUTH COUNTY ORDINANCE #310-A

WHEREAS, Kossuth County has heretofore enacted Ordinance #310-A – "An Ordinance Regulating, the Construction and Operation of Commercial Wind Energy Conversion Systems (WECS) in Kossuth County, Iowa (the "Ordinance"), and

WHEREAS, the Ordinance provides a limit for total name-plate production in Kossuth County in an amount not to exceed 700 megawatts; and

WHEREAS, on or about November 20, 2020 Kossuth County issued a WECS permit (Permit Number: WECS-2020-01) to Ledyard Windpower, LLC/Duke Energy Renewables Wind, LLC ("Permittee") concerning a proposed project known as Ledyard Windpower Project ("Ledyard Windpower Project"); and

WHEREAS, Kossuth County has previously issued other WECS permits to other entities, which as those projects are completed, would bring the total name-plate production within the County to **approximately** 600 megawatts, inclusive of the megawattage proposed by the Permittee for the Ledyard Windpower Project; and

WHEREAS, in Resolution 10-22-19-01 Kossuth County imposed a moratorium on the filing and/or processing of any new Notice of Intent to Construct or WECS Construction Permit Applications under Kossuth County Ordinance 310-A which was set to expire on October 22, 2020. The moratorium did not apply to the project known as Ledyard Windpower Project; and

WHEREAS, in Resolution 10-27-20-01 Kossuth County imposed an extension of the moratorium established in Resolution 10-22-19-01, and

WHEREAS, the County Board of Supervisors intends to refer a proposed change to the ordinance to the Regional Zoning Commission in accordance with Article XXIV of the Kossuth County Zoning Ordinance for consideration and processing; and

WHEREAS, the County desires to continue to preserve the status quo pending a review and potential amendment of Kossuth County Ordinance 310-A concerning the megawatt cap set forth therein and associated amendments.

NOW, THEREFORE, BE IT RESOLVED, by the Kossuth County Board of Supervisors that a moratorium extended by Kossuth County Resolution 10-27-20-01 is hereby extended on the filing and/or processing of any new Notice of Intent to Construct or WECS Construction Permit Applications under Kossuth County Ordinance 310-A. The moratorium shall sunset and be null and void on June 1, 2021. This moratorium shall not apply to the project known as Ledyard Windpower Project or have any impact on the WECS permit issued to Permittee.
