Kossuth County was awarded \$145,913.10 on February 24, 2021 as part of Local Government Relief Funds to counties from remaining FEMA local match funding and previously allocated funding for small cities to the counties they reside in. The CARES Act funding provides relief for expenses that have been incurred directly by counties and will cover the amount of Comp time acquired by Dave Penton.
