RESOLUTION TO ESTABLISH A SPEED ZONE P46 (140th Avenue) Kossuth County Resolution #06-15-21-01

WHEREAS, Kossuth County has received a request to review the speed limit along a portion of Kossuth County Route P64 (140th Avenue), and

WHEREAS, the Board of Supervisors is empowered under authority of Sections 321.255 and 321.285, of the Code of Iowa, to determine upon the basis of an engineering and traffic investigation, that the speed limit of any secondary road is greater than is reasonable and proper under the conditions existing, and may determine and declare a reasonable and proper speed limit, and

WHEREAS, such investigation has been completed by the Kossuth County Engineer's Office, and

NOW, THEREFORE, BE IT RESOLVED, by the Kossuth County Board of Supervisors that a speed limit be established and appropriate signs erected at the locations described as follows:

On Kossuth County Route P46 (140th Avenue) beginning at a point measured north from the intersection with P46 and 110th Street approximately 800 feet and ending at a point measured northerly from the intersection with P46 and 110th Street approximately 4,000 feet, 45 m.p.h.

This resolution shall be in effect when the signs have been erected and removed.
