Motion by Plathe and 2nd by Loss to approve the purchase of three 140 Motor Graders from Ziegler for a total price of \$1,072,524.45 less trade for a 1995 140G Motor Grader, Machine Number 135 for \$61,400.

Purchase price is \$1,011,124.45 for the three machines. Chairman Tjarks called for a roll call vote: Stecker: yes, Casey: yes, Loss: yes, Plathe: yes, Tjarks: yes. Motion carried.

Motion by Tjarks and 2nd by Loss to approve the purchase of a 2011 Skyjack SJIII3226 Scissors Lift from Ziegler Cat for a purchase price of \$54,000less trade value for 1995 Skyjack SJIII3220 (Kossuth County Equipment #813) of \$1,200 for a net purchase price of \$4,200. Motion carried unanimously.

The Annual Financial Assurance Report for the Landfill is postponed until after the yearly Audit is done.

Discussion was held regarding the partial assignment of WECS Construction Permit 2019-01 from Wisconsin Power & Light Company to Kossuth County Wind, LLC. Kossuth County Auditor Tammy Eden read a letter dated April 4, 2022 from Alan D. Mawdsley in support of the assignment.

RESOLUTION TO PARTIALLY ASSIGN WECS CONSTRUCTION PERMIT

WHEREAS, Wisconsin Power and Light Company ("WPL") currently holds all right, title and interest in and to that certain Wind Energy Conversion System Construction (WECS) Permit No. WECS-2019-01, issued by Kossuth County, Iowa to Kossuth Wind Energy LLC on October 1, 2019, and as assigned to WPL pursuant to that certain Assignment and Assumption Agreement dated October 3, 2019, by and between Kossuth Wind Energy LLC and WPL (the "WECS Permit"); and

WHEREAS, the WECS Permit authorizes, subject to the terms and conditions therein, the construction and operation of eighty-four (84) wind turbines and related equipment, including meteorological towers, to be placed on eighty-four (84) permitted parcels sufficient to site a two hundred fifty (250) MW wind generating facility, as described in the application for the WECS Permit and in accordance with all applicable federal, state, and local regulations; and

WHEREAS, WPL has completed the construction of, and owns and operates, a one hundred fifty (150) MW wind generating facility known as the Kossuth Phase I Project consisting of fifty-six (56) turbines sited on fifty-six (56) permitted parcels, subject to the terms and conditions of the WECS Permit; and

WHEREAS, Kossuth County Wind, LLC, a Delaware limited liability company ("<u>KCW</u>"), seeks to construct, own, and operate a wind powered electric generating facility with a proposed nameplate capacity of approximately seventy (70) MW, consisting of 27 turbines located on 27 parcels, each identified in the WECS Permit, in Kossuth County, Iowa (the "<u>Kossuth Phase II Project</u>") adjacent to the Kossuth Phase I Project; and

WHEREAS, KCW is a joint venture between WPL and Kossuth County Wind Holdings ("<u>Wind Holdings</u>"), a wholly-owned, indirect subsidiary of NextEra Energy Resources, LLC ("<u>NEER</u>"); and

WHEREAS, Wind Holdings, is the managing member of the joint venture and is responsible for the development, construction, operation and maintenance of the Kossuth Phase II Project in compliance with the terms and conditions of the WECS Permit, as applicable to the Kossuth Phase II Project; and

WHEREAS, the Kossuth County Ordinance #310 - B allows for the transfer of assignment of the WECS Permit, subject to the consent and written approval of the Kossuth County Board of Supervisors and the Zoning Administrator upon a finding that "a proposed transferee has the financial and operational responsibility to assume all obligations required of the Permit Holder under this Ordinance and the Ancillary Agreements listed in Section V [of the Ordinance]"; and

WHEREAS, WPL and Wind Holdings desire that WPL partially assign and transfer to KCW an interest in the WECS Permit as necessary to facilitate and authorize the development, construction, operation, and maintenance of the Kossuth Phase II Project; and

WHEREAS, WPL and Wind Holdings have jointly requested, by separate correspondence to the Kossuth County Zoning Administrator (the "Joint Request"), that the Kossuth County Board of Supervisors provide any approval of the partial assignment of the WECS Permit to KCW as may be necessary for KCW to construct, own and operate the Kossuth Phase II Project, provided that no such action of Kossuth County, Iowa affects or impairs, in any manner, the existing rights of WPL arising under the WECS Permit; and

WHEREAS, Wind Holdings has provided written assurances to the Board that KCW is able and ready to assume the financial and operational responsibility for the WECS Permit, the Road Use and Repair Agreement and Public Drainage System Agreement, the Emergency Response Plan (the "Ancillary Agreements"), and Decommissioning Plan, as applicable to the Kossuth Phase II Project; and

WHEREAS, to secure KCW's performance of its obligations under the WECS Permit, as partially assigned to KCW, NEER and Wind Holdings, on behalf of KCW, have agreed to provide to Kossuth County, (a) within thirty (30) days of the approval of the partial assignment and during construction of the Kossuth Phase II Project, a non-cancellable, perpetual performance bond, surety bond or letter of credit in an amount no less than \$2,000,000.00, (or an amount otherwise reasonably determined by the County Zoning Administrator), and (b) a decommissioning bond in accordance with the requirements of the Decommissioning Plan applicable to decommissioning the Phase II Project ((a) and (b) the "Financial Assurance"), such Financial Assurance to be issued by either a United States office of a commercial bank, insurance, or trust company (which is not an affiliate of KCW) organized under the laws of the United States (or any state or a political subdivision thereof), or the United States branch of a foreign bank (which is not an affiliate of KCW), in either case having assets of at least ten billion dollars (\$10,000,000,000) and having credit ratings from two of S&P, Moody's or Fitch of at least A3 (in the case of Moody's) or A- (in the case of S&P or Fitch); and

WHEREAS, KCW, Wind Holdings, NEER agree that, other than an assignment for purposes of obtaining financing (including to tax equity investors holding only non-controlling interests in the Kossuth Phase II Project), any transfer or assignment of an interest in KCW, or assets of KCW, to any entity that is not a wholly-owned, direct or indirect subsidiary of NEER or WPL will be deemed a transfer within the meaning of Kossuth County Ordinance #310 - B and, as such, will require the approval of Kossuth County under the terms of such ordinance; and

WHEREAS, the Board finds, based on the Joint Request and all of the foregoing, that KCW has the financial and operational responsibility to assume all obligations of required of KCW under the Ordinance, the WECS Permit, the Ancillary Agreements, and Decommissioning Plan, as applicable to the Kossuth Phase II Project; and

WHEREAS, the Board finds that KCW has the knowledge and financial resources to develop and operate the Kossuth Phase II Project in a manner that complies with the WECS Permit, Ancillary Agreements, and Decommissioning Plan, as applicable to the Kossuth Phase II Project, and will have the financial and operational responsibility to assume all obligations required by the WECS Permit holder under the Ordinance, Ancillary Agreements, and Decommissioning Plan as applicable to the Kossuth Phase II Project;

NOW THEREFORE BE IT RESOLVED, based on the foregoing and the Joint Request, the Board approves the partial assignment of the WECS Permit to KCW such that KCW shall assume all rights and obligations of the partially assigned WECS Permit as applicable to the Kossuth Phase II Project.

BE IT FURTHER RESOLVED, the partial assignment of the WECS Permit to KCW with respect to the Kossuth Phase 2 Project shall not impair, limit, or otherwise affect the rights and obligations of WPL under the WECS Permit with respect to the Kossuth Phase I Project.

BE IT FURTHER RESOLVED, on and after the date hereof, KCW shall comply with all terms and conditions of the WECS Permit as applicable to the Kossuth Phase II Project, all conditions and requirements identified in the application submitted for such WECS Permit as applicable to the Kossuth Phase II Project, and all agreements with Kossuth County in connection with the Kossuth Phase II Project. As partially assigned, the WECS Permit shall be enforceable against KCW with respect to the Kossuth Phase II Project and the design, construction, operation and maintenance thereof.
