Motion by Loss and 2nd by Plathe to sign the 28E Agreement between the Iowa Department of Transportation and Kossuth County. Motion carried unanimously.

Kossuth County Engineer Doug Miller opened bids for the Secondary Road Department Equipment purchase. Motion by Plathe and 2nd by Tjarks to approve the purchase of a Caterpillar 289 D3 Compact Track Loader from Ziegler Caterpillar for a total price of \$84,469, less the trade of a 2009 Caterpillar 279 Compact Track Loader, Machine Number 304 for \$23,500 for a purchase price of \$60,969 for the machine.
