The board acknowledged the Budget Status Report.

The Secondary Road Department recognized Phil Goche as he will be retiring at the end of this month.

A Wellness update was given, and the Wellness Committee minutes were acknowledged.

General Assistance Director Dona Nielsen gave a monthly update.

Motion by Waechter and 2<sup>nd</sup> by Nath to postpone the conditional purchase agreement of land in Section 2 & 3 of Riverdale Township and Section 34 of Cresco Township by Conservation for two weeks for Kendall Stumme to look into the buffer. Motion carried unanimously.

Motion by Stecker to set the salary for the Planning & Zoning Administrator at \$15,000/year to start and to incorporate that amount with the starting wages for the Weed Commissioner and Sanitarian. Motion failed for lack of second.

Motion by Waechter and 2<sup>nd</sup> by Stecker to set the Planning & Zoning Administrator Salary at \$10,000/year. Chairman Stecker called for a roll call vote: Plathe: no, Tjarks: no, Waechter: yes, Nath: yes, Stecker: yes. Motion carried 3-2.

Motion by Tjarks and 2<sup>nd</sup> by Waechter to eliminate items B., C., & H. from the Zoning Administrator Job Description and to look at the Planning & Zoning Ordinance at some period in the future. Motion carried unanimously.

Motin by Nath and 2<sup>nd</sup> by Stecker to approve the job descriptions for the Weed Commissioner, Sanitarian and Planning & Zoning Administrator. All Ayes except Supervisor Tjarks voted nay.

Motion by Waechter and 2<sup>nd</sup> by Stecker to post the job opening for the Sanitarian/Weed Commissioner/Planning & Zoning Administrator on the Kossuth County Website, the Kossuth County Advance and to follow the handbook as far as posting. The posting will refer applicants to the available job description online. The deadline for the position will be set for December 3, 2024, or until the

position is filled. Job qualifications will be listed as higher education or other qualifications are preferred. Advertisement fees will be taken out of the Supervisors budget. Motion carried unanimously.

Motion by Nath and 2<sup>nd</sup> by Plathe to stop using the variable pharmacy rebate program offered in Kossuth County's current Wellmark Health Plan and begin using Wellmark's constant pharmacy rebate program outlined in Wellmark's letter dated September 12, 2024, and on file in the HR Office on January 1, 2025. Chairman Stecker called for a roll call vote: Plathe: yes, Tjarks: yes, Waechter: yes, Nath: yes, Stecker: yes. Motion carried unanimously.

Motion by Nath and 2<sup>nd</sup> by Waechter to authorize and give its permission to Janice Guenther, Corwith, IA to install 72 feet of 18" Ø Class III reinforced concrete pipe through 170<sup>th</sup> Street, approximately 540 feet east of the southwest corner of Section 27, Prairie Township, Kossuth County. Permit number 10-35-2024 is on file in the Kossuth County Engineer's Office. Motion carried unanimously.

Discussion was held with the Kossuth County Engineer/Zoning Administrator.

A discussion was held regarding DD 40 televised Main Tile. Supervisor Nath will get more information from the drainage clerk and proceed from there.

Motion by Plathe and 2<sup>nd</sup> by Waechter to have the supervisors handle their requests as follows: Supervisor Stecker: Request 2024-116 DD 165; Request 2024-119 DD 129; Request 2024-120 DD 4 Lat 79; Request 2024-121 DD 133; Supervisor Tjarks: Request 2024-117 DD 78; Request 2024-118 DD 7 OD. Motion carried unanimously.

Discussion was held with the Kossuth County Auditor and Kossuth County Board of Supervisors.

Motion by Tjarks and 2<sup>nd</sup> by Nath to adjourn at 11:06 A.M. Motion carried unanimously.
