Motion by Wymore and 2nd by Mc Gregor that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Irving Valvick, Ledyard, IA, to install a new drain tile across 460th Street. The crossing will involve cutting through 460th Street and installing new 12" Ø Class 3 reinforced concrete pipe. The crossing is approximately 635 feet west of the intersection of 460th Street and 130th Avenue. Work will be in Section 1 Harrison Township and Section 36 Grant Township. Permit number 08-20-2014 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Tjarks and 2nd by Plathe that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Midland Power Cooperative, Humboldt IA, to repair a faulted buried electric cable in the shoulder of a gravel road. Work will be in the shoulder of 80th Avenue, 2,090 feet north of the intersection with 240th Street, work will be in Section 20 Union Township. Permit number 08-21-2014 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Wymore and 2nd by Tjarks that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Interstate Power and Light, Dubuque, IA, to perform maintenance work on power poles. This work will involve replacing as necessary, crossarms and hardware on existing poles, replacing poles when necessary, and maintaining pole lines along current right of way.
