Public discussion and committee reports were held.

Lahoma Counts from Elderbridge Agency on Aging gave FY 2006 annual report. Elderbridge consist of many services, assessment/intervention, case management assessments, chore, congregate/homebound meals, homemaker, information and assistance, legal assistance, personal care, respite care, representative payee, senior health program, and transportation. The total in Kossuth County was \$149,077.92. They are requesting for FY 2008, \$9,807.75.

Kossuth County Community Foundation submitted their 2007 budget. The Foundation is a nonprofit organization created by and for the people of Kossuth County. The Foundation's main goals are to serve the people of Kossuth County who share a common concern, improving the quality of life in Kossuth County and to promote philanthropy and attract additional funds to assist donors in creating lasting legacies in all areas, Arts and Culture, Community Affairs and Development, Education, Environmental Education and Protection, Health, Historic Preservation and Human Services. They are requesting for FY 2008, \$4000.
