Members of the Kossuth County Community Foundation and the Kossuth County Care Team were present to give their annual report and Budget Requests for FY 12-13. Scott Curtis gave the monthly report for Kossuth Regional Health Center and to present the Board with the FY 12-13 Budget Request for the Medical Examiner.

Motion by Plathe and 2<sup>nd</sup> by Elsbecker to authorize and give permission to Unite Private Networks, LLC to install fiber optic cable within Kossuth County conduits according to the contract between Kossuth County, Iowa and Unite Private Networks, LLC. And further to approve and authorize the chair of the Board of Supervisors to sign the contract. Motion carried.

Motion by Elsbecker and 2<sup>nd</sup> by McGregor that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Century Link, Mason City, IA, to install new buried service wire. Work will involve plowing approximately 2610 feet in the east right of way of 115<sup>th</sup> Avenue, beginning at a pedestal in the SE intersection of 180<sup>th</sup> Street and 115<sup>th</sup> Avenue.
