## SET DATE FOR HEARING ON INTERNAL TIF DEBT RESOLUTION

The Board of Supervisors of Kossuth County, Iowa met at the Kossuth County Courthouse, Algona, Iowa, on February 4, 2014, at 10:15 a.m. The Chairperson presided and the roll being called, the following named Supervisors were present: McGregor, Wymore, Tjarks, Plathe and Besch.

The County Auditor reported that was necessary for the Board to set a date for a public hearing on a resolution to authorize a noncurrent debt in the form of an internal tax increment loan. Supervisor Wymore introduced the resolution next hereinafter set out and moved its adoption, seconded by Supervisor Besch; and after due consideration thereof by the Board, the Chairperson put the question upon the adoption of the resolution, and the roll being called, the following named Supervisors voted: Besch: yes, Tjarks: yes, Wymore: yes, Plathe: yes, McGregor: yes

Motion by Tjarks and 2<sup>nd</sup> by Plathe to adopt Resolution #02-04-14-01 to fix a date of meeting at which it is proposed to approve a Resolution authorizing Tax Increment Loan. Chairman McGregor called for a roll call vote: Besch: yes, Tjarks: yes, Wymore: yes, Plathe: yes, McGregor, Yes

## **RESOLUTION #02-04-14-01**

To fix a date of meeting at which it is proposed to approve a Resolution authorizing Tax Increment Loan

WHEREAS, Kossuth County, Iowa (the "County"), pursuant to and in strict compliance with all laws applicable to the County, and in particular the provisions of Chapter 403 of the Code of Iowa, has established the Kossuth County Buffalo Township Economic Development Urban Renewal Area (the "Urban Renewal Area"); and

WHEREAS, the Board of Supervisors (the "Board") has identified a county road improvement project to be undertaken in the Urban Renewal Area (the "Project"); and

WHEREAS, the Board wants to create an internal loan (the "Internal Loan") to pay the cost of the Project, which would be repaid from future incremental property tax revenues produced in the Urban Renewal Area; and

WHEREAS, Section 331.479 of the Code of Iowa requires a County to hold a hearing before establishing the Internal Loan;

NOW THEREFORE, IT IS RESOLVED by the Board of Supervisors of Kossuth County, Iowa as follows:

Section 1. This Board shall meet on the 4<sup>th</sup> day of March, 2014, at 8:25 o'clock a.m., at the Kossuth County Courthouse, Algona, Iowa, at which time and place a public hearing will be held and action will be taken to approve the Internal Loan.

Section 2. Notice of the proposed action, the time when and place where the meeting will be held, shall be published, at least once not less than four days and not more than twenty days before the meeting, in a legal newspaper of general circulation in the County. Said notice shall be in substantially the following form:

The Board of Supervisors of Kossuth County, Iowa, will meet on the 4<sup>th</sup> day of March, 2014, at the Kossuth County Courthouse Algona, Iowa at 8:25 o'clock a.m., to hold a public hearing on incurring noncurrent debt (the "Noncurrent Debt") in amount not to exceed \$300,000 for the purpose of paying the costs, to that extent, of undertaking the construction of county road improvements in the Kossuth County Buffalo Township Economic Development Urban Renewal Area (the "Project").

At that time and place, oral or written objections may be filed or made to the proposal to incur the Noncurrent Debt.

The Noncurrent Debt will be in the form of an internal advance from the County's Rural Services Basic Fund for the payment of costs of the Project and will be repaid from incremental property tax revenues. The Noncurrent Debt will be incurred pursuant to authority contained in Chapter 403 and in Sections 331.478 and 331.479 of the Code of Iowa.
