Motion by McGregor and 2nd by Froehlich that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Iowa Lakes Electric Cooperative, Estherville, Iowa, to install single phase overhead electrical power line on 80th Avenue beginning at 390th Street and ending at 380th Street. Poles and anchors will be set just inside of west ROW line of Section 7 Greenwood Township, as per agreement and permit number 05-02-05 on file in the Kossuth County Engineer's Office. Ayes all, Nays none. Motion carried unanimous.
