General Supplemental fund will not have revenues until taxes are collected and expenditures will be incurred before tax collection. This loan will be repaid by June 30, 2005.

WHEREAS, it is desired to make appropriations for each of the different officers and departments for the fiscal year beginning July 1, 2004, in accordance with session 331.434 sub section 6, Code of Iowa at 100% of the total budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Kossuth County, Iowa as follows:

Section 1:

The amounts itemized by fund and by department or office on the attached schedule are hereby appropriated for the resources of each fund so itemized, to the department or office listed in the first column on the same line of the attached schedule.

Section 2:

Subject to the provision of other county procedures and regulations, and applicable state law, the appropriations authorized under Section 1 shall constitute authorization for the department or officer listed to make expenditures or incur obligations from itemized fund, effective July 1, 2004.

Section 3:

In accordance with section 331.437 Code of Iowa, no department or officer shall expend or contract to expend any money or incur any liability, or enter into any contract which by its terms involves the expenditure of money for any purpose in excess of the amounts appropriated pursuant to this resolution.

Section 4:

If at any time during the Fiscal 04-05 budget year the Auditor shall ascertain that the available resources of a fund for that year will be less than said fund's total appropriations, she shall immediately so inform the Board and recommend appropriate corrective action.

Section 5:

The Auditor shall establish separate accounts for the appropriations authorized in Section 1, each of which shall indicate the amount of the appropriation, the amounts charged thereto, and the unencumbered balance. The Auditor shall report the status of such accounts to the applicable department and officer Quarterly, or sooner as needed during the 04-05 fiscal budget year.

Section 6:

All appropriations authorized pursuant to this resolution lapse at the close of business June 30, 2005. Ayes: all, Nays: none. Motion carried unanimous.

Motion by Cink and 2nd by Elsbecker that Maurice Kollasch be re-appointed Commissioner for the Veteran Affairs Board with term to expire June 30, 2007. Ayes all, Nays none. Motion carried unanimous.

Motion by Besch and 2nd by Cink to approve appointment of James Grandgenett to the position of Director of the Kossuth County Veteran's Affairs. Ayes all, Nays none. Motion carried unanimous.

Motion by Froehlich and 2nd by Besch to approve the following Resolution for interfund operating transfer: WHEREAS, it is desired to authorize the Auditor to periodically transfer sums from the general basic and rural services basic funds to the secondary road fund during the 04-05 fiscal budget year, and

WHEREAS, said transfers must be in accordance with section 331.342, Code of Iowa,

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Kossuth County, Iowa as follows:

Section 1:

The total maximum transfer from the general basic fund to the secondary road fund for fiscal year beginning July 1, 2004 shall not exceed the sum of \$138,296 and the total maximum transfer from the rural services basic fund to the secondary road fund for the fiscal year beginning July 1, 2004 shall not exceed the sum of \$1,882,600.

Section 2:

Within 3-10 days of being notified of the apportionment of current property taxes, state replacements against levied property taxes, mobile home taxes, military service tax credit replacements, or to the general basic or rural services basic funds, the Auditor shall order a transfer from said fund to the Secondary road.

Section 3:

The amount of the transfer required by Section 2 shall be equal to the apportionment made under Section 2 to the general basic or rural services basic fund, respectively, multiplied by the ratio of said funds total maximum transfer to the secondary road fund, to the sum of said funds total current property tax levy, total mobile home taxes, total military service tax credit replacements, and total livestock credit replacements.

Section 4:

Not withstanding the provisions of sections 2-7-3 of this resolution, total transfers to the secondary road fund shall not exceed the amounts specified in Section. 1.

Section 5

Not withstanding the provisions of section 2 and 3, the amount of any transfer shall not exceed available fund balances in the transferring fund.

Section 6:

The Auditor is directed to correct her books when said operating transfers are made and to notify the treasurer and county engineer of the amounts of said transfers.
