Gene Elsbecker attended meeting of the Central Iowa Juvenile Detention Center in Eldora, Iowa, July 11, 2003. Discussion was held of investing money in the same bank or to use banks in other counties represented on the board. They will have \$400,000 available to invest July 1, 2003. They have 38 trackers in place. One resident of Kossuth County was there for five days the past month. Informal discussion on building more facilities in the future and have had land offers in the Eldora area. Webster County has a committee of three that decide or deny pharmaceutical claims for their county and much discussion was held.

Robert Cink gave report on letter from the Rabiner Treatment Center. The county attorney is checking on the land acquisition or mainly to square up the land. Their renovation cost estimate is approximately \$250,000, including cash outlay. They have been endorsed by the school districts and plan to have meetings with local businesses to buy materials they will need in renovation.
