RESOLUTION 07-20-04-01

WHEREAS, there has been presented to the Board of Supervisors of Kossuth County, Iowa, for the consideration of said Board a certain proposed Plat and Dedication of "GREEN ACRES, KOSSUTH COUNTY, IOWA", covering the following described real estate, to-wit:

A subdivision of that part of the Northwest Quarter of the Northeast Quarter of Section 35, Township 96 North, Range 29 West of the 5^h P.M., Kossuth County, Iowa, described as follows:

Commencing at the Northwest corner of the Northeast Quarter of said Section 35; thence South 0°30.5' West 960.67 feet along the westerly line of said Northeast Quarter; thence South 89°45.2' East 122.59 feet to the point of beginning at the easterly right-of-way line of U.S. Highway #169 at a point 60 feet from the centerline of said Highway and at a point previously recorded as 961 feet South and 129.7 feet East of the Northwest corner of said Northeast Quarter; thence continuing South 89°45.2' East 180.00 feet along a line parallel with, and 100 feet distant northerly from, the North line of the property originally conveyed to Harry Moore, by Warranty Deed recorded in Deed Record Book #90, Page 36, in the Office of the Kossuth County Recorder (and memorialized by the Land Survey recorded in Book #3, Page 8, of Land Plats in said office); thence South 0°27.0' East 97.77 feet; thence North 89°32.2' East 60.00 feet; thence North 0°27.0' West 197.03 feet; thence South 89°45.2' East 300.06 feet; thence North 0°27.0' West 307.00 feet; thence North 89°45.2' West 540.06 feet to the easterly right-ofway line of U.S. Highway #169; thence South 0°27.0' East 407.00 feet along said Highway right-of-way line and parallel with the centerline of said Highway to the point of beginning, containing 4.49 acres;

From which it appears that Richard A. Besch and Marsha L. Besch, husband and wife, are the owners of said real estate and that the said Richard A. Besch and Marsha L. Besch, husband and wife, desire to plat and dedicate the same as "GREEN ACRES, KOSSUTH COUNTY, IOWA", and which Plat and Dedication are presented to this Commission for approval; and

Kossuth County, Iowa Resolution No. 8

RESOLUTION APPROVING THE APPLICATION TO THE IOWA DEPARTMENT OF ECONOMIC DEVELOPMENT REQUESTING CERTIFICATION OF AN ENTERPRISE ZONE IN KOSSUTH COUNTY.

WHEREAS, Kossuth County, Iowa, (hereinafter referred to as "County") is a political subdivision organized and existing under the laws and the constitution of the State of Iowa (hereinafter referred to as "State"); and

WHEREAS, the purpose of Iowa Code Sections 15E.191 through 15E.196 is to promote new economic development in economically distressed areas by encouraging communities to target resources in ways that attract productive private investment; and

WHEREAS, administrative rules adopted by the Iowa Department of Economic Development (hereinafter referred to as "Department") require the County to approve, by resolution, the establishment of an enterprise zone and the submission of an application requesting certification to the Iowa Department of Economic Development Board (hereinafter referred to as "Board"); and

WHEREAS, Iowa Code Section 15E.196 enumerates incentives or assistance for an eligible business located in an enterprise zone. For purposes of determining the incentives or assistance provided in Section 15E.196, "eligible business" means a business which has been approved to receive incentives and assistance by the Department pursuant to application as provided in Section 15E.196 of the Iowa Code. One of the incentives listed is the County for which an eligible enterprise zone is certified may exempt from all property taxation all or a portion of the value added to the property upon which an eligible business locates or expands in an enterprise zone and which is used in the operation of the eligible business.

NOW. THEREFORE. BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF KOSSUTH COUNTY AS FOLLOWS:

SECTION 1. The County certifies that it is an eligible participant and meets the following required distress criteria pursuant to Iowa Code Section 15E.194: (Choose all that apply – must have at least 2)

- The County has an average weekly wage that ranks among the bottom twenty-five counties in the state based on the 2000 annual average weekly wage for employees in private business.
- The County has a family poverty rate that ranks among the top twenty-five counties in the state based on the 2000 census.
- The County has experienced a percentage population loss that ranks among the top twenty-five counties in the state between 1995 and 2000.
- The County has a percentage of persons sixty-five years of age or older that ranks among the top twenty-five counties in the state based on the 2000 census.

SECTION 2. The County hereby requests enterprise zone certification from the Board, pursuant to Iowa Code Section 15E.192, for **14 acres** described below, which the County verifies the total amount of land designated as enterprise zones under Iowa Code Section 15E.192, Subsections 1 and 2, and any other enterprise zones certified by the Department, excluding those approved pursuant to Iowa Code Section 15E.194, Subsection 4, does not exceed in the aggregate one (1) percent of the total county area (623,248 or 623,251.20 acres).

SECTION 3. The County shall provide a copy of this resolution to the Department and shall file this resolution with the Kossuth County Assessor.

SECTION 5. The provisions of this resolution are hereby declared to be sever able and if any section, phrase, or provision shall be for any reason declared to be invalid, such declaration shall not affect the validity of the remainder of the sections, phrases, and provisions hereof. SECTION 6. This resolution shall become effective immediately upon its passage and approval.
