RESOLUTION #06-01-09-01

RESOLUTION REGARDING CONSTRUCTION CONTRACT TO CONFORM THE JUDGE'S BENCH IN THE KOSSUTH COUNTY COURTROOM TO THE AMERICANS WITH DISABILITIES ACT.

WHEREAS, Iowa Code Section 331.341, states that when the estimated total cost of a public improvement, other than improvements which may be paid for from the secondary road fund, exceeds the competitive bid threshold in section 26.3, or as established in section 314.1B, the board shall follow the competitive bid procedures for governmental entities in chapter 26 and the contract letting procedures in section 384.103; and

WHEREAS, Iowa Code Section 26.3(1) states that if the estimated total cost of a public improvement exceeds the competitive bid threshold of one hundred thousand dollars, or the adjusted competitive bid threshold established in section 314.1B, the governmental entity shall advertise for sealed bids for the proposed public improvement by publishing a notice to bidders. The notice to bidders shall be published at least once, not less than four and not more than forty-five days before the date for filing bids, in a newspaper published at least once weekly and having general circulation in the geographic area served by the governmental entity.

WHEREAS, Iowa Code Section 26.3(2) states that a governmental entity shall have an engineer licensed under chapter 542B, a landscape architect licensed under chapter 544B, or an architect registered under chapter 544A prepare plans and specifications, and calculate the estimated total cost of a proposed public improvement; and

WHEREAS, the county is responsible for providing a courtroom for legal matters to be resolved; and

WHEREAS, the Americans with Disabilities Act, 42 U.S.C. §12101, states that it is a violation to fail to provide reasonable accommodation to the known physical or mental limitations of a qualified individual with a disability, unless to do so would impose an undue hardship. Undue hardship means that the accommodation would require significant difficulty or expense. Judge Donald Bormann is a qualified individual with a disability under the Act and a District Associate Judge for Kossuth County.

THEREFORE BE IT HEREBY RESOLVED that the Kossuth County Board of Supervisors after following the procedures set out in Chapter 26 of the Iowa Code hereby accepts the lowest bid of \$42,698 by Bob Becker Construction and awards the construction contract to Bob Becker Construction for the courtroom accessibility project.

RESOLUTION REQUESTING ELECTION FOR LOCAL SALES AND SERVICES TAX AND ESTABLISHING PROPOSED USE OF LOCAL SALES AND SERVICES TAX REVENUES

WHEREAS, the City of Algona, Iowa, has a local sales and services tax, also known as the local option sales tax, which is currently in effect until June 30, 2014; and

WHEREAS, the City Council of the City of Algona, Iowa, has determined that it would be in the best interest of the City to hold an election for the continuation of the one percent (1%) local sales and services tax which would begin on July 1, 2014; and

WHEREAS, the City Council of the City of Algona, Iowa, is of the opinion that the election for the continuation of the local sales and services tax should occur on the same date as the next regular City election which would be the first Tuesday in November of 2009; and

WHEREAS, the City Council of the City of Algona, Iowa, has further determined the City's intended use for the revenue if the electors vote to impose the local sales and services tax; and

WHEREAS, the City Council of the City of Algona, Iowa, requests that the Kossuth County Commissioner of Elections submit the question of the imposition of a local sales and services tax to the registered voters of the City of Algona, Iowa, at the same time that the regular City election is held on the first Tuesday in November, 2009.

NOW, THEREFORE, BE IT RESOLVED by the Kossuth County Board of Supervisors as follows:

- 1. That the Kossuth County Commissioner of Elections submit the question of the imposition of a local sales and services tax to the registered voters of the City of Algona, Iowa, at the same time that the regular City election is held on the first Tuesday in November, 2009.
- 2. That the ballot for said election include the following language:
