Public Discussion and Committee Reports:

Richard Schiek and Doug Miller discussed layout of the clock and showed map to supervisors as to how it will be on the courthouse lawn. During the week trees will be trimmed and footings will be poured. They expect the clock to arrive around the July  $1^{\rm st}$  date. The dedication will be July  $11^{\rm th}$ , 2003 at 4:15 p.m.

Don Besch reported on the  $3^{rd}$  Judicial Correction Facility. Audit was performed with no serious problems. Breakdown of inmates was 18% inmates have Mental Health Problems. 92% inmates have substance abuse problems of which 48.3% is Alcohol and 31.7% is Meth. 2-4% Schizophrenia, 19% Depression, 4% Bi Polar Disorder, 30% Anxiety Disorder, 12% Post Tramatic Stress Disorder.

Clerk of Court for County will be appointed in June. Clerks in existing county can apply.

Bob Cink gave report of North Iowa Area Council of Government which raised cost of transit to \$1.00. To cut cost they will be taking some transits out of service from 37 to 24 ½ units. Kossuth at present has two units.

Letter was handed out from Stein Law Office, L.L.P. regarding Iowa Construction Permit for Industrial Swine Confinement for Supervisors to read.

Gene Elsbecker and Don McGregor attended for Kossuth County Juvenile Detention Center at Eldora. With 15 counties, they had 100% attendance. They have been awarded the Tracking Contract for the State of Iowa. They will have one full time supervisor and one full time tracker. During the past month Kossuth County has had no one at the facility.

Bob Cink reminded Supervisors to appoint person to NIACOG Board.

Motion by Cink and  $2^{nd}$  by Froehlich to approve beer permit for ABATE. Ayes: all Nays: none. Motion carried unanimous.

Motion by Elsbecker and 2<sup>nd</sup> by Cink to approve the 28E Agreement with Iowa DNR for well permits. Ayes: all Nays: none. Motion carried unanimous.

Jack Bradley stated that the State of Iowa will be taking \$25.00 of our private well permit money from now on.

Motion by Besch and  $2^{nd}$  by Froehlich to raise fees for private well permits from \$50.00 to \$75.00. Ayes: all Nays: none. Motion carried unanimous.

Motion by Besch and 2<sup>nd</sup> by Cink to approve Gravel Purchase Agreement with Howard & Gloria West, Ann Petersen and Kathryn Petersen in Section 31, Township 99 North, Range 30 West, Kossuth County. Ayes: all Nays: none. Motion carried unanimous. Agreement on file in the Kossuth County Engineer's Office.

Motion by Besch and 2<sup>nd</sup> by Cink to approve application for fireworks at 1007 230<sup>th</sup> Street, Algona, Iowa. Ayes: all Nays: none. Motion carried unanimous.

Motion by McGregor and 2<sup>nd</sup> by Elsbecker that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Iowa Lakes Electric Cooperative, of Estherville, IA to construct single phase, 7200 volt underground distribution line in Swea Township, Section 27, as detailed on permit number 03-06-05 on file in the Kossuth County Engineer's Office. Ayes: all Nays: none. Motion carried unanimous.

Margo Underwood and Pam Osgood presented Air Service 21 from the Mason City Airport. This is a pilot project to add more flights and more seats. They are working with Northwest and will need a budget for media and marketing of \$105,257. Mason City has contributed \$25,000, Cerro Gordo County \$12,500, and \$30,000 from the airport commission. There are eight counties connected with NIACOG they plan to visit and ask for \$10,000 for this project. There will be a two year window to support this project.

Outstanding Mental Health claims will be paid prior to April 1, 2003. Discussion on Mental Health Contract, no action taken as more information needed. Discussed substance abuse and our position and a letter will be available at time of commitment that the Clerk of Court can provide.

Evaluation of CPC will be done in the next week.
