Motion carried 4 to 1 with Besch being the NO vote.

Motion by Wymore and 2nd by McGregor to award the contract for the following project let on June 10, 2014; MSC-1-2014 thru MSC-7-2014 Blacktop Service Co. and & Subsid. of Humboldt, Iowa for \$391,788.50 and further to approve and authorize the chair of the Board of Supervisors to sign contracts and bonds when the appropriate contract documents are returned to the Kossuth County Engineer. Motion carried 4 to 1 with Besch being the NO vote.

Motion by Tjarks and 2nd by Plathe that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to EC Source Services LLC, Story City, IA, to drill test holes for soil samples. Work will involve using a drill mounted on a truck frame and parking as far off the traveling roadway as possible. Testing will be completed the same day.
