The money for the Bancroft Clinic to build a facility with the goal of providing quality health care and emergency services to residents and industry in the northern half of Kossuth County.

The money to the Kossuth County Community Foundation. Main goals are to serve the people improving the quality of life in Kossuth County and to promote philanthropy and attract additional funds to assist donors in creating lasting legacies in all areas, Arts and Culture, Community Affairs and Development, Education, Environmental Education and Protection, Health, Historic Preservation and Human Services.
