Motion by McGregor and 2nd by Tjarks that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Louis McEnroe, Algona, IA, to install drain tile under 80th Avenue. The crossing will involve excavating a trench and installing a 30" tile under 80th Avenue, approximately 315 feet south of the intersection of 240th Street and 80th Avenue between Section 29 and 30 of Union Township. Permit number 10-52-2013 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Wymore and 2nd by Besch that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Midland Power Cooperative, Humboldt IA, to construct three phase electric overhead line to service an irrigation load. Work will involve removing 4 single phase poles in the north right of way of 180th Street and installing 4 new three phase overhead poles in the south right of way of 180th Street for 750 feet with a directional bored under 180th Street to existing acreage. The work will be in Section 20 and 29 Cresco Township. Permit number 11-56-2013 is on file in the Kossuth County Engineer's Office. Motion carried.
