Motion by Besch and 2nd by Wymore to approve the agenda. Motion carried.

Motion by Plathe and 2nd by Elsbecker to approve the minutes of the previous meeting as read. Motion carried.

Motion by Wymore and 2nd by Elsbecker to appoint Bernice Walker to a 4 year term expiring December 31, 2014 as Lotts Creek township trustee. Motion carried.

Scott Curtis was present to give the monthly report for Kossuth Regional Health Center.

Motion by Besch and 2nd by Wymore to abate the property tax on parcel #910-21-07-286-008. Motion carried.

Motion by Wymore and 2nd by Plathe to approve advertising for a full time Environmental Health Director. Motion carried.

Motion by Besch and 2nd by Wymore that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Northwest Telephone Cooperative Association, Havelock, IA, to do new and maintenance work on fiber, cable and phone lines. Work will begin in the northeast corner of the intersection of 40th Avenue and 140th Street. Work will begin in the east right of way of 40th Avenue in Section 10, Garfield Township and proceed north 2 miles on 40th Avenue crossing 150th and 160th Street. Then west across 40th avenue and connecting to an existing node and proceeding east 0.4 mile in the north right of way of 160th Street to existing node. Permit number 11-11-28 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by McGregor and 2nd by Plathe that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Paul Hamilton, Bancroft, IA, to install new 12" diameter drain tile under 350th Street. Work will involve excavating approximately 2100 feet east of the intersection of 350th Street and 100th Avenue, between Sections 27 and 34 Greenwood Township. Permit number 11-11-29 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by McGregor and 2nd by Plathe be it resolved that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Paul Hamilton, Bancroft, IA, to install 15" corrugated metal pipe for transporting hog manure under the roadway, crossing 350th Street approximately 2100 feet east of 100th Avenue, located 2100 feet east of the northwest corner of Section 34, Greenwood Township as per agreement and permit number MP 11-11-01 on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Elsbecker and 2nd by Wymore that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Warren Waltman, Algona, IA, to install new 18" diameter drain tile under 280th Street. Work will involve excavating approximately 1300 feet east of the northwest corner of the intersection of 280th Street and 180th Avenue, between Section 1 Plum Creek Township and Section 36 Portland Township. Permit number 11-11-30 is on file in the Kossuth County Engineer's Office. Motion carried.

Public discussion and committee reports were held followed by Drainage and Public Hearings for Drain 33 Main Tile and Drain 20 Lateral 2 of Main 1.
