Motion by McGregor and 2<sup>nd</sup> by Besch to approve the claim to County Social Services in the amount of \$340,000 for Purchased Administration. This is the first payment of the \$740,000 that was budgeted for FY 13-14. Motion carried.

Motion by McGregor and 2<sup>nd</sup> by Besch to approve Resolution #10-08-13-02 which authorizes the temporary closure of roadway when necessary for construction. Motion carried.

#### **RESOLUTION #10-08-13-02**

WHEREAS, Section 306.41 of the Code of Iowa provides for the temporary closing of sections of roadway when necessary because of construction, and

WHEREAS, the County Engineer has been authorized by a previous resolution of this Board of Supervisors to execute the requirements of Section 306.41 regarding temporary road closures, and

WHEREAS, bridge replacement project BROS-C055(143)—8J-55-55 will require that 490<sup>th</sup> Street between 240<sup>th</sup> Avenue (R14) and 250<sup>th</sup> Avenue (East County Line) be closed to all traffic, and

NOW, THEREFORE, BE IT RESOLVED, by the Kossuth County Board of Supervisors that the above described roads be closed and proper signs be erected for the duration of the construction project as determined by the County Engineer.

BE IT FURTHER RESOLVED, that upon completion of the construction work, as determined by the County Engineer, the road shall be opened to the traveling public without further action of this board.

Motion by McGregor and 2<sup>nd</sup> by Wymore that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Fred Schmidt, Whittemore, IA, to install a new drain tile across 50<sup>th</sup> Avenue. The crossing will involve cutting through 50<sup>th</sup> Avenue and installing 24" dual wall solid gasketed pipe. The crossing is approximately 1,340 feet north of the intersection of 50<sup>th</sup> Avenue and 170<sup>th</sup> Street. Work will be in Sections 27 and 26 of Whittemore Township. Permit number 10-49-2013 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Wymore and 2<sup>nd</sup> by McGregor that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Fred Schmidt, Whittemore, IA, to install a new drain tile across 180<sup>th</sup> Street. The crossing will involve cutting through 180<sup>th</sup> Street and installing 18" diameter Class IV reinforced concrete pipe. The crossing is approximately 2,615 feet east of the intersection of 40<sup>th</sup> Avenue and 180<sup>th</sup> Street. Work will be in Sections 22 and 27 of Whittemore Township. Permit number 10-50-2013 is on file in the Kossuth County Engineer's Office. Motion carried.

Drainage was held followed by Discussion with Kossuth County Auditor followed by Board Discussion and Committee Reports.  On motion adjournment was taken until October 15, 2013.
