KOSSUTH COUNTY ORDINANCE NUMBER 1-2011

TITLE: AN ORDINANCE READOPTING THE EXISTING COUNTY CODE OF KOSSUTH COUNTY, IOWA:

BE IT ENACTED by the Board of Supervisors of Kossuth County, Iowa:

Section 1. <u>Purpose</u>. Code of Iowa Section 331.302(9) requires that once every five years a County shall compile its Code of Ordinances. This ordinance readopts ordinances already in effect, adopts ordinances that became effective after the last readoption and repeals any ordinance deemed no longer necessary to the operation of Kossuth County, Iowa, or to the health, safety, and welfare of its citizens.

Section 2. <u>Readoption of Current Code</u>. The following ordinances have been previously adopted and enacted into law and were duly published as the law provides. They are stated herein by number and subject matter and by the authority of the Kossuth County Board of Supervisors, comprise Kossuth County Code of Ordinances:

AN ORDINANCE FOR THE REDISTRICTING & REPRECINCTING OF KOSSUTH COUNTY FROM THE 2010 CENSUS AS REQUIRED BY IOWA CODE [49.3(4), 331.209 – 331.210A]

SECTION1. <u>PURPOSE</u>: The purpose of this ordinance is to change the existing boundaries for the districts and precincts of Kossuth County to comply with current laws due to the 2010 census.
