Public Discussion & Committee Report:

Gene Elsbecker handed out a Central Iowa Juvenile Detention Center Net Worth Report for September 30th, 2003 This will be on file and can be viewed in Auditor's office. Kossuth County had two residents for the month of September for a total of 11 days. For the current year, Kossuth County has had a total of 29 days. Economic Development sent a letter of thank you for the \$50,000 for the Revolving Loan Fund. Senator Berl Priebe stated, he did not feel he was treated fairly with the sale of land and the Care Facility. He had asked if he could get a 10 to 20 year tax abatement and an option to buy 10 acres, also wanted County Attorney to check the Code and wanted everyone treated the same. Ron Peck agreed and thought the land price was not enough. He also stated the land should have changed hands in 30 to 45 days. Ron Peck discussed ABATE and road, stating if a public hearing came up, he could fill it up with people against it. Lee Froehlich stated he had many phone calls against.

Motion by Froehlich and 2nd by Elsbecker to open the public hearing for the proposal for the sale of 3.75 acres adjacent to the Kossuth County Care Facility, labeled Parcel "B". Ayes: all Nays: none. Motion carried unanimous. Absent: Cink

Bob Cink joined in by phone for the next two motions.

Motion by Besch and 2^{nd} by Froehlich to close the public hearing on sale of 3.75 acres to Rabiner Treatment Center. Ayes: all Nays: none. Motion carried unanimous.

RESOLUTION

RE: Proposal for sale of a 3.75 acre tract of land adjacent to the Kossuth County Care Facility, labeled Parcel "B" in Plat of Survey located in the SW ¼ NW ¼ Section 16-95-29 to Rabiner Treatment Center.

WHEREAS, the Rabiner treatment center has conditioned its purchase of the Kossuth County Care Facility upon the ability to acquire the additional land set out in this proposal; and

WHEREAS, the Kossuth County Board of Supervisors recognizes that the development of the former Kossuth County Care Facility by the Rabiner Treatment Center is beneficial to the County for many reasons, including but not limited to, the economic development impact and the elimination of future expense for care and upkeep of the building site; and

WHEREAS, the sale of the parcel would be advantageous to Kossuth County; and

WHEREAS, the Code of Iowa sets forth the procedure for the sale of property that is no longer needed for the purpose it was acquired by a county; and

WHEREAS, pursuant to Section 331.361(2), Iowa Code, the Kossuth County Board of Supervisors sets forth the following proposal which will be presented at a public hearing on October 14th, 2003, at 10:00 a.m.:

Parcel B, legally described as:

That part of the Southwest Quarter of the Northwest Quarter of Section 16, Township 95 North, Range 29 West of the 5th P.M., Kossuth County, Iowa, described as follows:

Commencing at the West Quarter Corner of said Section 16; thence N0°00'W (assumed bearing) along the West line of the Northwest Quarter of said Section 16 a distance of 324.34'; thence N90°00'E 575.00' to the point of beginning; thence continuing N90°00'E 290.00'; thence N0°00'W 562.77'; thence N90°00'W 290.00'; thence S0°00'W 562.77' to the point of beginning, containing 3.75 acres, more or less

shall be sold to Rabiner Treatment Center at a price of \$1,466.67 per acre for a total of \$5,500.00.

NOW, THEREFORE, BE IT RESOLVED, that the Kossuth County Board of Supervisors hereby sets forth its proposal for the sale of Parcel B pursuant to Section 331.361(2) Iowa Code.

It was on motion by Supervisor Elsbecker, and seconded by Supervisor Cink, that the foregoing resolution be adopted as read. Roll Call vote: Besch, no Cink, yes Elsbecker, yes Froehlich, no McGregor, yes. Motion carried.
