## REGULAR OCTOBER SESSION

The Board of Supervisors met pursuant to adjournment. Present were: Don McGregor, Chairman, Eugene Elsbecker, Bob Cink, Don Besch and Lee Froehlich. Absent: none.

Motion by Besch and 2<sup>nd</sup> by Froehlich to approve minutes of previous meeting as read. Ayes: all Nays: none. Motion carried unanimous.

Motion by Cink and 2<sup>nd</sup> by Elsbecker to approve the agenda. Ayes: all Nays: none. Motion carried unanimous.

Public Discussion & Committee Report:

Thank you read from Kossuth County EMS and the Crisis Center. Jim Kelley has completed Kossuth County Emergency Operations Plan, Kossuth County Annex P Emergency Operations Plan Hazardous Materials, and Kossuth County Part B Mitigation, Part C Recovery, and Terrorism. They can be viewed in Auditor's Office.

Bob Cink reported on Halloween Hike with about 400 kids. The Nature Center has about \$17,000 which they will be using some for consultants and a laptop computer. Bob Cink attended a board meeting in Spencer where they are looking into building a new building.

Don Besch reported on 911 meeting. Potential for NOAA Weather to be installed on Ringsted Telephone Company Tower and become operational yet this fall. New fold up maps should be here in November. Lee Froehlich reported on the Care Team and what they do. During the past month 15 families had children removed from home because of Meth.

Gene Elsbecker attended the Bio Terror alert in Bancroft. Algona and Bancroft will be the sites of medication and immunization in event of disaster. Don McGregor had checked on statements made by Senator Priebe that we were not playing on level playing field in sale of County Home. The Public Notice was published and no sealed bid was received from Senator Priebe. Bob Cink stated this unfortunate this has happened. Gene and Bob have done a lot of work with this and went through the legal procedures to submit bids and feel everyone had a chance to bid.

Elderbridge Annual Report, Lahoma Counts:

Lahoma Counts gave the Elderbridge Agency on Aging fiscal year 2003 annual report. Many were in attendance and told us the service they provided in Kossuth County. The FY2005 Match Fund Request was presented to the Board

## **KOSSUTH COUNTY RESOLUTION # 10-28-03-01**

WHEREAS, Section 321.345 of the Code of Iowa provides for local authorities to establish and erect stop signs, and

WHEREAS, an engineering study has been completed by the Kossuth County Engineer's Office, and

WHEREAS, the study indicates a need for stop signs for all traffic at the intersection of Kossuth County's Route B40 (210<sup>th</sup> Street), Kossuth County's Route P16 (20<sup>th</sup> avenue) and Whittemore's 5<sup>th</sup> Street near the Northwest Corner of section 8, T-95N, R-30W, Whittemore Township, Kossuth County, and

WHEREAS, the Whittemore City Council has scheduled to act on an ordinance to install stop signs at the mentioned location at their meeting on November 3, 2003.

NOW, THEREFORE, BE IT RESOLVED, by the Kossuth County Board of Supervisors:

That stop signs be installed for all traffic at the intersection of Kossuth County's Route B40 (210<sup>th</sup> Street), Kossuth County's Route P16 (20<sup>th</sup> avenue) and Whittemore's 5<sup>th</sup> Street near the Northwest Corner of section 8, T-95N, R-30W, Whittemore Township, Kossuth County.

This resolution shall be in effect upon passage of this resolution and Whittemore's Ordinance, and after stop signs are erected.
