Parcel #23-1117-300-004 will be an abatement for the 2013 Assessment Year and Parcel #21-06-300-003 will be an abatement for the 2013 and the 2014 Assessment Years. Motion carried.

There were no applications for buffer strip ban or applications for fireworks permits.

Motion by Wymore and 2nd by Plathe to appoint Shara Long as our Kossuth County Wellness Coordinator effective today; September 2, 2014. Motion carried.

Motion by Tjarks and 2nd by Besch that the Board of Supervisors of Kossuth County, Iowa does hereby authorize and give its permission to William Goche, Bancroft, IA, to install a new drain tile across 160th Avenue. The crossing will involve cutting through 160th Avenue and installing new 12" diameter Class 5 reinforced concrete pipe. The crossing is approximately 2,440 feet south of the intersection of 360th Street and 160th Avenue. Work will be in Section 28 and 27, Ramsey Township. Permit number 09-23-2014 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Plathe and 2nd by Tjarks that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Algona Municipal Utilities, Algona, IA, to replace underground primary electric cable and complete a loop. Work will involve boring along private property on the west side of River Road, and crossing approximately 4,685 feet north of Highway 169 from 2307 River Road to 2304 River Road in Section 35 and 36, Union Township. Permit number 09-25-2014 is on file in the Kossuth County Engineer's Office. Motion carried.

No action was taken on the item Discussion/Decision Tile crossing for William and Mary Goche due to the permit being issued during Construction within ROW.

Discussion was held with Mid American Energy MVP3 KW Project.

Motion by Wymore and 2nd by Tjarks that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to MidAmerican Energy, Urbandale, IA, to remove old H frame structures and construct 345KV lines. The work will involve construction of 345 kV overhead electric transmission lines, reconstruction of 161 kV overhead electric transmission line and removal of H frame structures used for old 161 kV line along current right of way.
