Voter pre-registration deadline is 5:00 P.M., May 20th, 2024 at the Kossuth County Auditor's Office. Absentee ballots are available in the County Auditor's office during regular business hours.

Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on Election Day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, 3) cast a provisional ballot and provide proof of identity/residence at the Kossuth County Auditor's office by June 6th, 2024 at noon. Election Day Registrant attestors must provide an approved form of identification.
