## BOARD PROCEEDINGS November 14, 2017 REGULAR NOVEMBER SESSION

The Board of Supervisors met pursuant to adjournment. Present were: Don McGregor, Chairman, Don Besch, Jack Plathe, Roger Tjarks and Pam Wymore.

Public discussion was held followed by discussion with Secondary Road Foreman.

Motion by Tjarks and 2<sup>nd</sup> by Besch to approve the agenda and the minutes of the previous meetings dated October 31, 2017 and November 13, 2017. Motion carried.

Motion by Plathe and 2<sup>nd</sup> by Wymore to approve the 1<sup>st</sup> Reading and consideration of Ordinance #115, an Ordinance To Establish the Limited Use of Engine Brakes and Compression Brakes in Kossuth County, Iowa. There were not any written or verbal comments received from the public. Chairman McGregor called for a roll call vote: Wymore: yes, Tjarks: yes, Plathe: yes, Besch: yes, McGregor: yes. Motion carried 5 to 0.

Motion by Wymore and 2<sup>nd</sup> by Tjarks that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Midland Power Cooperative, Jefferson, IA, to bore electric under 70<sup>th</sup> Avenue 2580 feet north of 170<sup>th</sup> Street. Work will be in Section 25, Whittemore Township and Section 34, Cresco Township. Permit number 10-45-2017 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Plathe and 2<sup>nd</sup> by Besch that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Ron Monson, LuVerne, IA, to install 20 feet of 24" diameter CMP and 56 feet of 18" diameter Class 3 reinforced concrete pipe by cutting through 180<sup>th</sup> Avenue, 2600 feet south of 170<sup>th</sup> Street. The crossing is between Sections 35 and 36 Irvington Township. Permit number 11-46-2017 is on file in the Kossuth County Engineer's Office. Motion carried.

Discussion with Kossuth County Engineer/Kossuth County Zoning Administrator was held.

The Board of Supervisors acknowledged the County Conservation Annual Report for 2016-2017 as presented by Kendall Stumme.

Drainage was held.

Discussion was held on the Ledyard Windpower Update.

Motion by Wymore and 2<sup>nd</sup> by Tjarks to approve the Application of Ledyard Windpower, LLC for Easement through Drainage District Right of Way to construct a road over lateral 22 of Kossuth County Drainage District 152 located in the southwest quarter of Section 1, T-99N, R-28W of the 5<sup>th</sup> P.M. Ledyard Township. Chairman McGregor called for a roll call vote: Wymore: yes, Tjarks: yes, Plathe: yes, Besch: no, McGregor: yes. Motion carried 4 to 1 with Besch being the No vote.

Motion by Plathe and 2<sup>nd</sup> by Wymore to approve Resolution #11-14-17-01 which is a resolution to grant Ledyard Windpower, LLC, a Texas Limited Liability Company a Drainage District Crossing Easement. Chairman McGregor called for a roll call vote: Wymore: yes, Tjarks: yes, Plathe: yes, Besch: no, McGregor: yes. Motion carried 4 to 1 with Besch being the No vote.
