Motion by Besch to reduce the Kossuth County Compensation Boards Recommendation by 80%, motion died for a second.

Motion by Tjarks and 2<sup>nd</sup> by Wymore to accept the recommendation of the Kossuth County Compensation Board which would allow for a 3.00% increase for the Board of Supervisors and County Sheriff, 6.00% increase for the County Auditor, 2.00% increase for the County Attorney and a 4.00% increase for the County Recorder and the County Treasurer. This motion is for budget purposes only and final action of the recommendation will be made at the Kossuth County Budget Hearing for FY 18-19. Chairman McGregor called for a roll call vote: Wymore: yes, Tjarks: yes, Plathe: yes, Besch: yes, McGregor: yes. Motion carried.

The Board of Supervisors acknowledged the Retirement of Jim Grandgenett, Veteran's Affairs Director.

The Board of Supervisors were provided with copies of the November transfers that Amber Garman made from General Basic Fund to the Secondary Road Fund in the amount of \$3,408.57 and from the Rural Basic Fund to the Secondary Road Fund in the amount of \$19,160.37. The transfers were made on December  $4^{th}$ , 2017.

Compass Pointe was present to give their budget request for FY 2018-2019.

The Fair Board was present to give their budget request for FY 2018-2019.

Motion by Plathe and 2<sup>nd</sup> by Wymore that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Alliant Energy (IP&L), Spirit Lake, IA, to remove power poles and bore approximately 2705 feet in the south Right of Way of 285<sup>th</sup> Street between US Hwy 169 and 120<sup>th</sup> Avenue, then south 1120 feet in the west Right of Way of 120<sup>th</sup> Avenue. Work will be in Section 35, of Burt Township. Permit number 12-49-2017 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Wymore and 2<sup>nd</sup> by McGregor to approve the bid from North Iowa Telecom in the amount of \$33,444.00 for the Security Camera for the Jail. Motion carried.
