Motion by Tjarks and 2nd by Plathe to approve the Assignment of Tax Sale Certificate 2009-09163 on parcel #800-14-24-359-001 in Burt, Iowa to the City of Burt for a \$10.00 assignment fee. Chairman McGregor called for a roll call vote: Wymore: Yes, Tjarks: Yes, Plathe: Yes, Besch: Yes, McGregor: yes. Motion carried 5-0.

Motion by Besch and 2nd by Wymore to authorize the chairman of the Board of Supervisors go sign a two year renewal agreement with Avesis, a vision company. The policy and rates will be effective July 1, 2018 through June 30, 2020. The premium is 100% employee participation. Motion carried.

Motion by Wymore and 2nd by Plathe to approve and sign letter of support to the Algona Public Library Project. Chairman McGregor called for a roll call vote: Wymore: Yes, Tjarks: Yes, Plathe: Yes, Besch: Yes, McGregor: Yes. Motion carried 5-0.

Motion by Tjarks and 2nd by Wymore to approve bid from Steinman Insulation Roofing LLC for \$71,796.00 for the Election Building Roof. Chairman McGregor called for a roll call vote: Wymore: Yes, Tjarks: Yes, Plathe: Yes, Besch: No, McGregor: Yes. Motion carried 4-1 with Besch being the No vote.

The Board of Supervisors acknowledged the February Transfers made by Kossuth County Auditor on March 2nd, 2018 from the General Basic Fund to the Secondary Road Fund in the amount of \$2,745.95 and from Rural Basic Fund to Secondary Road Fund in the amount of \$22,038.10.

Bob Lincoln's email in regards to County Social Services in Kossuth County was turned over to the Kossuth County Attorney.

Motion by Wymore and 2nd by Plathe that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Alliant Energy (IPL), Marshalltown, IA, to remove overhead, then place underground cable, junction cabinet and pad mount transformer. Work will be in the south right of way of 280th Street for 3890 feet west of 80th Avenue, and crossing the road at 707 280th Street. Work will be in section 6, Union Township and Section 31, Burt Township. Permit number 03-04-2018 is on file in the Kossuth County Engineer's Office, see map attached to permit for installation details. Motion carried.

Motion by Tjarks and 2nd by Besch to approve Resolution #03-20-18-01 which is a resolution that provides for the temporary closing of sections of roadway when necessary because of construction. Motion carried.

WHEREAS, Section 306.41 of the Code of Iowa provides for the temporary closing of sections of roadway when necessary because of construction, and

WHEREAS, the County Engineer has been authorized by a previous resolution of this Board of Supervisors to execute the requirements of Section 306.41 regarding temporary road closures, and

WHEREAS, bridge replacement project BROS-C055(159)--5F-55 and BROS-C055(160)--5F-55 requires 90th Avenue between 280th Street and 290th Street be closed to all traffic, and

NOW, THEREFORE, BE IT RESOLVED, by the Kossuth County Board of Supervisors that the above described roads be closed and proper signs be erected for the duration of the construction project as determined by the County Engineer.

BE IT FURTHER RESOLVED, that upon completion of the construction work, as determined by the County Engineer, the road shall be opened to the traveling public without further action of this board.
