WHEREAS, On May 22, 2018, the Kossuth County Board of Supervisors established a moratorium on the authorization of all airports or landing fields in Kossuth County by the Kossuth County Board of Adjustment for 180 days or until the Board of Supervisors removes the moratorium by similar resolution, whichever is earlier, and

WHEREAS, the Kossuth County Board of Supervisors amended Kossuth County Ordinance #310 so that possible conflicts between landowners and wind energy developers are addressed, and

WHEREAS, The Kossuth County Board of Supervisors desires to remove the established above mentioned moratorium.

WHEREFORE, the Kossuth County Board of Supervisors removes the moratorium on the authorization of all airports or landing fields in Kossuth County by the Kossuth County Board of Adjustment that was established on May 22, 2018.
