WHEREAS, the Kossuth County Board of Supervisors is the holder of municipal solid waste permit number 55-SDP-01-75C, and

WHEREAS, the Kossuth County Sanitary Landfill closure was completed September 30, 2008, and

WHEREAS, the Code of Iowa requires permit holders of municipal solid waste sanitary landfill permits to maintain a separate post closure account to accumulate resources for the payment of post closure costs, and

WHEREAS, Kossuth County has an 81002 Landfill Post Closure Fund whose balance was \$578,435.81 on August 1, 2018 and

WHEREAS, an Engineer's Estimated Cost Post Closure is \$588,280, and

WHEREAS, approximately \$9,844.19 is required to be deposited into the Landfill Post Closure Fund to fully fund it and comply with Iowa Department of Natural Resources.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF KOSSUTH COUNTY that \$9,844.19 that are in the 81000 Transfer Station Fund be transferred to the 81002 Landfill Post Closure Fund.
