Gary Merrill Conducted a presentation on the HX of EMS in Kossuth County to date. Needs assessment etc.

Gary gave an explanation and description of the levels / certifications in EMS

Drivers – None certified only required to be CPR certified and a valid Driver's license.

EMR – Was the First Responded, they have a basic assessment skill level. Tight restrictions. Apply O2, CPR, Assessment

EMT – More advanced assessment, basic airway adjusts, defibrillation, some basic medication (Eppi Pen, ASA, Patient assisted NTG, inhalers)

AEMT – add IV skills and some baseline cardiac arrest IV medications EPPI, Atropine, Amiodarone

Paramedic – 2 Years of College Advanced Airway Management, any medications available and allowed by medical director. Allowed to give any medication other than Insulin.

CCP – Yet a higher level of Certifications. Able to transport ICU patients with Balloon pumps, multiple drips, vent, cvp monitoring

Nurse Exceptions – Licensed RN authorized to operate on and Ambulance under there license. Must Have basic EMS Training.

Service Authorization -

Full Authorized – Able to provide said level of care 24 hrs. / day

Conditional authorized – Can sometimes provide this level of care

Transport – Certified to transport patients to a hospital

Non-Transport - Another service must come to transport the patient.

Spoke a little about simultaneous page and paramedic assist. And coverage areas.
