Discussion was held with Steve Brick in regards to the possibility of amending Ordinance 310A regarding a 2 mile setback for communities in Kossuth County.

Discussion was held about the approval of the Application for Wind Energy Conversion System Permit. Ordinance 310A is current law. Application for WECS Construction Permit was reviewed and said to be complete by Zoning Commissioner, Doug Miller. Time line to approve the application after Public Hearing is 30 days. The final plan was submitted on September 9th, 2019. According to dates and law, the Board of Supervisors are able to vote today, on the Application for the Construction Permit. Mr. Brick stated to his knowledge, there are no legal reasons for not approving the application. Mr. Brick also stated, that if a Supervisor is to vote no, they have to establish a legal reason that the application is incomplete at the time of their vote, it cannot be based on opinion.

RESOLUTION # 10-01-19-01 KOSSUTH COUNTY BOARD OF SUPERVISORS October 1, 2019

RESOLUTION APPROVING AN APPLICATION FOR WECS CONSTRUCTION PERMIT BY KOSSUTH WIND ENERGY LLC

WHEREAS, Kossuth County has heretofore enacted Ordinance #310-A – "An Ordinance Regulating, the Construction and Operation of Commercial Wind Energy Conversion Systems (WECS) in Kossuth County, Iowa (the "Ordinance"), and

WHEREAS, Kossuth Wind Energy LLC ("*KWE*") has, pursuant to the Ordinance, filed an Application for a WECS Permit to construct and operate a WECS in Kossuth County to be called Kossuth Wind Project (the "*Project*"), and

WHEREAS, the Application has been reviewed by the Zoning Administrator and found to be in conformity with the requirements of the Ordinance, and

WHEREAS, notice of the filing of the Application was mailed and published in accordance with the Ordinance, and

WHEREAS, notice of a public hearing on the Application was mailed and published in accordance with the Ordinance, and

WHEREAS, a public hearing was held by the Board of Supervisors on September 5, 2019, per the requirements of Iowa Law and the Ordinance, and

WHEREAS, following the public hearing, KWE submitted a Final Development Plan ("*FDP*") to the Zoning Administrator showing the final location of all turbines and other components comprising the Project, and

WHEREAS, the Kossuth County Board of Supervisors has considered the public comments, and, having reviewed the Application and the FDP, FINDS that the Application and the FDP are complete and in compliance with the terms of the Ordinance, that all notice requirements pertaining to the Application and the public hearing were complied with in accordance with the Ordinance and Iowa law, and that all other requirements under the Ordinance for issuance of a WECS Construction Permit have been satisfied, and

WHEREAS, the Kossuth County Board of Supervisors concludes that a WECS Construction Permit for the Project should be granted.

NOW, THEREFORE, BE IT RESOLVED, by the Kossuth County Board of Supervisors that the aforementioned Application and FDP of KWE be and hereby is approved; and the Kossuth County Zoning Administrator is hereby directed to issue a WECS Construction Permit to KWE for the construction and operation of the Project.

RESOLUTION # 10-01-19-02 KOSSUTH COUNTY BOARD OF SUPERVISORS October 1, 2019

Approval of the assignment and transfer of WECS Construction Permit 2019-01 by Kossuth Wind Energy LLC to *Wisconsin Power and Light Company*]

WHEREAS, Kossuth County has heretofore enacted Ordinance #310-A – "An Ordinance Regulating, the Construction and Operation of Commercial Wind Energy Conversion Systems (WECS) in Kossuth County, Iowa (the "Ordinance"), and

WHEREAS, October 1, 2019, the Kossuth County Board of Supervisors (the "*Board*") concluded that a WECS Construction Permit for the Kossuth Wind Project (the "*Project*") should be issued to Kossuth Wind Energy LLC ("*KWE*"), and

WHEREAS, on October 1, 2019, the Board directed the Zoning Administrator to issue a WECS Construction Permit for the Project to KWE, and

WHEREAS, on October 1, 2019, the Zoning Administrator issued WECS Construction Permit 2019-01 for the Project to KWE (the "*Permit*"), and

WHEREAS, Wisconsin Power and Light Company ("WPL") previously entered into an agreement to acquire the Project from KWE, and

WHEREAS, WPL and KWE expect to close on the sale of the Project, transferring ownership of the Project from KWE to WPL (the "*Transaction*"), and

WHEREAS, as part of the Transaction, KWE will assign and WPL will acquire, among other Project assets, the Permit and Ancillary Agreements (which include the Road Use and Repair Agreement and Public Drainage System Protection Agreement between EDF and Kossuth County, and the Emergency Response Plan), and Decommissioning Plan for the Project, and

WHEREAS, WPL has requested that the Zoning Administrator approve the transfer of the Permit from KWE to WPL, with such approval of the transfer to become effective as of the date of closing on the Project, and

WHEREAS, WPL provided written assurances to the Board that WPL is able and ready to assume the financial and operational responsibility for the WECS permit, the Ancillary Agreements and the Decommissioning Plan for the Project. WPL is a financially sound public utility that is regulated by the Public Service Commission of Wisconsin. In addition, The Public Service Commission of Wisconsin granted the Application of Wisconsin Power and Light Company for a Certificate of Authority for Construction, Installation, and Placement in Operation of a Wind Electric Generation Facility, Known as the Kossuth Wind Project, in Kossuth County, Iowa Case # 6680-CE-181 (PSC REF#356813) (Dated January 7, 2019) for a total estimated cost of \$223 million contemplating cost recovery through conventional ratemaking treatment, and

WHEREAS, the Board finds that WPL has the knowledge and financial resources to develop and operate the Project in a manner that complies with the WECS Permit, Ancillary Agreements, and Decommissioning Plan and, upon closing on the Transaction, will have the financial and operational responsibility to assume all obligations required by the Permit holder under the Ordinance and the Ancillary Agreements (as that term is defined in the Ordinance), and

WHEREAS, the Board finds that KWE's obligations and financial security required under the Decommissioning Plan (as the term is defined in the Ordinance) are contemplated to be transferred and assigned to WPL; and

WHEREAS, the Board concludes that the requirements under the Ordinance for the assignment and transfer of the Permit, the Ancillary Agreements and the Decommissioning Plan have been met.

NOW, THEREFORE, BE IT RESOLVED, by the Kossuth County Board of Supervisors that the transfer and assignment of the Permit, the Ancillary Agreements, and the Decommissioning Plan from KWE to WPL is approved, with such approval to become effective as of the date of closing on the Project and submission to the county of a fully executed transfer and assignment of all obligations including the Permit, the Ancillary Agreements and the Decommissioning Plan and submission of the financial security

and satisfaction of all other requirements of the ordinance, and he Zoning Administrator is hereby authorized to execute any documentation necessary to confirm such approval and effectuate such transfer and assignment of the same.

No discussion was held with Thomas S Reavely, Attorney for Kossuth County Citizens for Rural Property Rights regarding Kossuth Wind Energy Project, per Attorney Earl Hill, Mr. Reavely was unable to attend due to court. Mr. Hill appeared on his behalf. After approval of Construction Permit for WECS, Mr. Hill removed himself from the agenda and left.

Discussion with Kossuth County Auditor was held followed by Board Discussion and Committee Reports.
