Original purchase price was \$100,980 per trailer. New purchase price will be \$101,330 per trailer. Motion by Plathe and 2nd by Loss that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Corn Belt Power Cooperative to reconstruct a

High Voltage Electric Overhead Transmission Line from the substation at the Northwest corner of section 6, Wesley Township, south and east 7.5 miles to the County line. Work will be in Sections 6, 8-12, Wesley Township. Permit number 09-37-2020 is on file in the Kossuth County Engineer's Office. Chairman Plathe called for a roll call vote: Casey: yes, Stecker: yes, Loss: yes, Tjarks: yes, Plathe: yes. Motion carried.

Supervisor Loss left the meeting.

Motion by Stecker and 2nd by Tjarks to appoint Bolton & Menk as Engineer for Repair Request 2020-011 on DD4 Lateral 28 Tile. Chairman Plathe called for a roll call vote: Casey: yes, Stecker: yes, Loss: Absent, Tjarks: yes, Plathe: yes. Motion carried.

No decision was made on the Lotts Creek Project – Trees near former Whittemore Golf Course Bridge.

Motion by Tjarks and 2nd by Stecker to acknowledge the petition for cleanout of D.D. 82 main open ditch & Lateral 7 Open Ditch and to appoint Jacobson Westergard to look into the cleanout. Chairman Plathe called for a roll call vote: Casey: yes, Stecker: yes, Loss: Absent, Tjarks: yes, Plathe: yes. Motion carried.

No decision was made in regards to the teleconference with Palo Alto regarding payment of repair for TRI 84 Lateral 37E.

No decision was made in regards to review bills and work that was done on Drain 4 Open Ditch and Drain 4 Lat 24-33 Open Ditch.
