Home Improvement Structured Alteration (HISA) grant(s) pending for 2023 is 1 and total YTD are 0. Director Green has mailed 1 Brushy Creek Honor Flight Applications mailed out. Director Green completed on 1 Iowa Veterans' Home Application.

b. Update Directors Activities: Director Green updated the Commission on activities for April 2023.

c. Budget Review: Director Green and the Commission reviewed the monthly expense summary, GDX 5-year comparison of benefits for veterans of Kossuth County.
