Motion by Haas and 2nd by Stecker to approve the Kossuth County Treasurer's Semi-Annual Report. Motion carried unanimously.

Motion by Garman and 2nd by Waechter to approve the liquor license for Bottom of the Cup, LLC. Motion carried unanimously.

Motion by Stecker and 2nd by Nath to approve the liquor license for North Kossuth Golf Club. Motion carried unanimously.

Motion by Garman and 2nd by Haas to approve the appointment of Greg Casey as trustee for Cresco Township to fill a vacancy for Steve Mallory. Motion carried unanimously.

Discussion was held regarding an Animal Ordinance in Kossuth County. Supervisor Nath will speak with County Attorney Holmes regarding the completion of an ordinance, and it will be put back on the agenda on February 4, 2025.

Discussion was held regarding the composition of a Solar Ordinance. The board will review templates from other counties and will discuss it again on February 4, 2025.

A discussion was held regarding Wellmark Blue Cross Blue Shield insurance options. This discussion will continue next week with a representative from Wellmark.

There was no construction in ROW.

A discussion was held with the Kossuth County Engineer/Zoning Administrator.

The board acknowledged the drainage transfers by the Kossuth County Auditor's Office.

Tyler Conley from Bolton & Menk presented a report for DD 116. The board acknowledged the report and will talk to legal counsel regarding how to proceed.

A discussion was held with the Kossuth County Auditor and the ChKossuth County Board of Supervisors.

Budget workshops were held with Secondary Roads, Self-Insurance, and E-911.

The board continued budget workshops with Human Services and Non-Departmental.
