RESOLUTION TO AWARD CONTRACT: 2025 HMA Resurfacing

WHEREAS, the Board of Supervisors, hereafter referred to as "the Board", believes the *STP-S-C055(210)--5E-55, FM-C055(211)--55-55, FM-C055(212)--55-55,* hereafter referred to as "the project" is in the best interest of Kossuth County, Iowa, and the residents thereof. The project is defined as HMA resurfacing projects located at various locations throughout Kossuth County; and

WHEREAS, the Board has sought appropriate professional guidance for the concept and planning for the project and followed the steps as required by the Code of Iowa for notifications, hearings, and bidding/letting; and

WHEREAS, The Board finds this resolution appropriate and necessary to protect, preserve, and improve the rights, privileges, property, peace, safety, health, welfare, comfort, and convenience of Kossuth County and its citizens, all as provided for in and permitted by section 331.301 of the Code of Iowa; and

IT IS THEREFORE RESOLVED by Board to accept the bid from Mathy Construction Company in the amount of \$4,859,560.73 and awards the associated contract to the same;

BE IT FURTHER RESOLVED that all other resolutions or parts of resolutions in conflict with this resolution are hereby repealed. If any part of this resolution is adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the resolution or action of The Board as a whole or any part thereof not adjudged invalid or unconstitutional. This resolution shall be in full force and effect from and after the date of its approval as provided by law; and

BE IT FURTHER RESOLVED by the Board of Supervisors of Kossuth County, Iowa, that after receiving the necessary contract documents, including but not limited to, the contractor's bond and certificate of insurance, Douglas A. Miller, the County Engineer for Kossuth County, Iowa, be and is hereby designated, authorized, and empowered on behalf of the Board of Supervisors of said County to execute the contracts in connection with the afore awarded construction project let through the DOT for this county.

Permit number 04-08-2025 is on file in the Kossuth County Engineer's Office. Motion carried unanimously.

Motion by Stecker and 2nd by Haas to authorize and give its permission to Wright Tree Service, Des Moines, IA to spray Kossuth County Secondary Road Right of Way for the purposes of removing trees and brush under overhead power for ITC Midwest along: 460th Street beginning approximately 2,220

feet east of 180th Avenue on the north side of the road to 240th Avenue, section 36, Springfield Township and Sections 31-35 Hebron Township. The permit is on file in the Kossuth County Engineer's Office. Motion carried unanimously.

A discussion was held with the Kossuth County Engineer.

The Board of Supervisors discussed specifics to be listed in the Lease for the Emergency Response Complex.

Motion by Stecker and 2nd by Waechter to set April 15, 2025 at 8:00 A.M. as the date and time for the Public Hearing and first reading of the Animal Control Ordinance and to direct the Kossuth County Auditor to publish the notice. Motion carried unanimously.

The board discussed details that need to be included in a Solar Ordinance. Kossuth County Auditor Tammy Eden will convey that information along to the attorney appointed to work with us on the ordinance.

Motion by Stecker and 2nd by Waechter to appoint Ahlers & Cooney to work with the county on a Solar Ordinance and send the information to Attorney Maria Brownell. Motion carried unanimously.
