Section 4:	If at any time during the FY 25-26 budget year the Auditor shall ascertain that the Available resources of a fund for that year will be less than said fund's total Appropriations, the Auditor shall immediately so inform the board and recommend Appropriate corrective action.

.05 cents/hour at 5 years .10 cents/hour at 10 years .15 cents/hour at 15 years .20 cents/hour at 20 years .25 cents/hour at 25 years .30 cents/hour at 30 years and .05 cents/hour for every 5 years to follow Scale 1: Clerks/Support Staff in the Recorder, Treasurer, Attorney and Auditor's office \$41,600.00/year Starting Wage \$46,800.00/year at 6 months probationary \$50,542.47/year at 1 year Scale 2: Custodians \$23.40/hour Starting Wage \$24.96/hour 6 months probationary \$27.02/hour at 1 year Scale 3: Clerk/Driver's License Department \$46,800.00/year Starting Wage \$52,000.00/year 6 months probationary \$56,675.09/year at 1 year Scale 4: Victim Witness Coordinator in the County Attorney's Office \$44,000.00/year Starting Wage \$49,200.00/year 6 months probationary \$53,274.00/year at 1 year Scale 5: Office Manager in the Sheriff's Office

\$46,800.00/year Starting Wage \$52,000.00/year 6 months probationary \$55,521.44/year at 1 year
