The board discussed adding a high-deductible plan as an option for employees.

Dodge, Iowa to cut and cap a 2" gas main approximately 620' west of Hwy 169 in the north ditch of 190<sup>th</sup> Street and tap existing gas main with a 2" PL main approximately 900 feet west of Hwy 169 in the north ditch of 190<sup>th</sup> Street. Work will be in Section 14, Cresco Township. Permit 10-21-2025 is on file in the Kossuth County Engineer's Office. Motion carried unanimously.
